BY THE HEARING OFFICER:

On April 6, 2020, Prosperity Properties, Inc., d/b/a Omaha Supportive Living ("Applicant") Omaha, filed an application seeking authority as a common carrier in Nebraska intrastate commerce in the transportation of passengers by sedan and van between points in Douglas County over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and HHS Designation is yes. Notice of the Application was published in The Daily Record, Omaha, Nebraska, on April 7, 2020.

Timely protests were filed by Camelot Transportation, Inc.; Triumph Transportation, Inc.; Comstock Corporation d/b/a Action Cab; WHC NE, LLC d/b/a zTrip; WHC NE, LLC d/b/a Cornhusker Cab Company and zTrip; WHC NE, LLC d/b/a Happy Cab and zTrip; WHC NE, LLC d/b/a Checker Cab Company and zTrip; WHC NE, LLC d/b/a Yellow Cab Company and zTrip; and WHC NE, LLC d/b/a Safeway Cabs and zTrip.

A telephonic planning conference was held on September 24, 2020 to discuss a procedural schedule and hearing date. On December 7, 2020, Applicant filed a motion to amend its Application to seek status as a contract carrier instead of common carrier. Applicant would provide transportation services only for its own residential clients or individuals who receive services from Applicant. Applicant will provide services by sedan and van between points in Douglas County over irregular routes with HHS Designation.
