BY THE COMMISSION:

On January 7, 2020, the Nebraska Public Service Commission ("Commission"), on its own motion, opened the above-captioned docket to address those motor carriers not in compliance with the Commission's annual renewal requirements.

Pursuant to Neb. Rev. Stat. § 75-305, every regulated motor carrier and transportation network ("TNC") must pay an annual fee on or before January 1 and shall be delinquent March 1 each year after such permit or certificate has been issued. On November 2, 2020, the Transportation Department ("Department") sent a certified letter, return-receipt requested, to all regulated carriers, and electronic notice to all TNCs that renewal forms, annual fee payments, and proof of current insurance were due to the Commission by January 1, 2021, and would be delinquent on March 1, 2021. The letter also informed the recipients that failure to comply with these deadlines could result in suspension of operating authority until renewal forms, annual renewal fee payments, and proof of current insurance were received. A follow-up letter to those carriers not yet in compliance was sent on or about December 16, 2020.

O P I N I O N S A N D F I N D I N G S

The Commission may, on its own initiative after notice and hearing, suspend a Certificate of Public Convenience and Necessity or Permit of Authority for failure to comply with Neb. Rev. Stat. §§ 75-101 to 75-801.¹ The Department has determined those carriers not in compliance with the January 1st deadline, attached hereto as Appendix A. All carriers named in Appendix A are regulated motor carriers as defined by statute and are subject to Commission rules and regulations.² The Department, therefore, seeks an order suspending the Certificates of Public Convenience and Necessity or

Permits of Authority and requiring these carriers to cease and desist offering services as motor carriers pursuant to Neb. Rev. Stat. § 75-133 (2018) for failure to remit annual fees in compliance with Neb. Rev. Stat. § 75-305 (2018). The Department would seek reinstatement of such carriers once compliance has been achieved, or would seek further action if non-compliance continues beyond March 1, 2021.

Based on the above, the Commission finds that the carriers named in Appendix A should be ordered to show cause as to why the Commission should not suspend their Certificates of Public Convenience and Necessity or Permits of Authority and ordered to cease and desist offering services as motor carriers in Nebraska pursuant to § 75-133 for failure to remit annual fees in accordance with § 75-305. Hearing on this matter should be scheduled for **January 26, 2021 at 1:30 p.m.** in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska. To comply with Directed Health Measures, seating will be limited for public in-person attendance. Remote access to the hearing will be available via Webex and telephone. O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that each carrier listed in Appendix A be ordered to show cause as to why its Certificate of Public Convenience and Necessity or Permit of Authority should not be suspended and said carrier ordered to cease and desist offering services as motor carriers in Nebraska pursuant to § 75-133 for failure to remit annual fees in accordance with § 75-305.

IT IS FURTHER ORDERED that hearing on this matter is scheduled for **January 26, 2021 at 1:30 p.m.** as prescribed herein.
