BY THE COMMISSION:

On August 13, 2019, Price's Party Patrol, LLC ("Applicant"), Lexington, Nebraska, filed an application seeking to extend its authority as a common carrier to transport passengers between all points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and HHS Designation is no. Notice of the Application was published in The Daily Record, Omaha, Nebraska, on August 23, 2019.

On November 13, 2019, the protest filed by VIP Limousine, LLC, was granted. On November 19, 2019, the Commission entered an Order Granting Applicant's Motion to Amend its Application. On January 27, 2020, an Order was entered Granting the withdrawal of VIP Limousine's protest. As a result, the Application was then processed pursuant to the Commission Rule of Modified Procedure.

The Commission has attempted to contact Applicant regarding the pending application and the missing required affidavits of applicant and supporting shipper. Applicant has not contacted the Commission nor complied with the requirement to submit the required affidavits.

Based on the above, the Commission finds that a deadline for action to be taken by Applicant in this docket should be set. If the Commission does not receive any communication or direction from Applicant concerning this application by **January 28, 2021** the Commission will dismiss the application for failure to take timely action.
