BY THE COMMISSION:

On May 1, 2020, Party on the Go, LLC ("Applicant"), Kearney, Nebraska, filed an application seeking authority as a common carrier in Nebraska intrastate commerce in the transportation of passengers by bus in special party service between all point sin Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and HHS Designation is no. Notice of the Application was published in The Daily Record, Omaha, Nebraska, on May 11, 2020. No protests were filed, and the Application was processed pursuant to Commission Rule of Modified Procedure.

The Commission has attempted to contact Applicant regarding the pending application and the missing required affidavits of applicant and supporting shipper. Applicant has not contacted the Commission nor complied with the requirement to submit the required affidavits.

Based on the above, the Commission finds that a deadline for action to be taken by Applicant in this docket should be set. If the Commission does not receive any communication or direction from Applicant concerning this application by **January 28, 2021** the Commission will dismiss the application for failure to take timely action.
