BY THE COMMISSION:

On January 29, 2020, an application was filed by Brad Johnson d/b/a MVP Limousine ("Applicant"), Scottsbluff, Nebraska, seeking authority as a common carrier in Nebraska intrastate commerce in the transportation of passengers by limousine between points in Perkins, Chase, Thomas, Logan, Hayes, Hitchcock, Red Willow, Frontier, Sioux, Scotts Bluff, Banner, Kimball, Cheyenne, Morrill, Box Butte, Dawes, Sheridan, Garden, Duel, Grant, Arthur, Keith, Lincoln, McPherson, Hooker, and Cherry counties and points between said counties over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and HHS Designation is no. Notice of the Application was published in The Daily Record, Omaha, Nebraska, on February 25, 2020. No protests were filed; therefore, the Application was processed under the Commission Rule of Modified Procedure.

On May 5, the Commission entered an Order granting the

application¹; however, Applicant never finalized its approval by complying with Neb. Rev. Stat. §§ 75-305 (fees), 75-307 (insurance), and 75-308 (rates) (Cum Supp. 2020), and with the rules and regulations of the Commission. The Commission has attempted to contact Applicant by mail, email, and telephone regarding the required compliance documents. To date, Applicant has not contacted the Commission and has failed to complete the necessary compliance as laid out in the May 5, 2020 Order.

Based on the above, the Commission finds that a deadline for action to be taken by Applicant in this docket should be set. If the Commission does not receive any communication or direction from Applicant concerning this application by **January 28, 2021** the Commission will dismiss the application for failure to take timely action.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that a deadline for communication with the Commission by Brad Johnson d/b/a MVP Limousine, Scottsbluff, Nebraska, in Application B-2011 be, and is hereby, set for **January 28**, **2021**.

IT IS FURTHER ORDERED that if Brad Johnson d/b/a MVP Limousine fails to act by **January 28, 2021**, in Application No. B-2011, the Commission will exercise its authority to enter an order dismissing the application.
