## BY THE COMMISSION:

On February 4, 2020, Omaha's Very Own Party Bus, LLC ("Applicant"), Omaha, Nebraska, filed an application seeking authority as a common carrier in Nebraska intrastate commerce in the transportation of passengers by bus in special party and charter service between points in Douglas and Sarpy counties, and points between said counties, over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and HHS Designation is no. Notice of the Application was published in The Daily Record, Omaha, Nebraska, on May 15, 2020. No protests were filed, and the Application was processed pursuant to the Commission Rule of Modified Procedure.

On July 28, 2020, the Commission entered an Order Granting the Application. On December 7, 2020, Applicant verbally informed the Commission that it would no longer wish to pursue the application. Commission staff informed Applicant that such a request must be made in writing. To date, the Commission has yet

to receive a written request to dismiss the Application.

## ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that a deadline for written communication with the Commission by Omaha's Very Own Party Bus, LLC, in Application B-2012 be, and is hereby, set for **January 28, 2021**.

IT IS FURTHER ORDERED that if Omaha's Very Own Party Bus, LLC, fails to act by **January 28, 2021**, in Application No. B-2012, the Commission will exercise its authority to enter an order dismissing the application.
