On December 9, 2020, Lunjini Medical Transportation, LLC ("Applicant"), LaVista, Nebraska, filed an application for authority to establish its rates as follows:

O P I N I O N A N D F I N D I N G S

Applicant is a Nebraska Limited Liability Company with its principal place of business in LaVista, Nebraska. On November 4, 2020, Applicant was authorized in Application No. B-1956 to transport passengers by van in open class service between points in Douglas, Sarpy, Dodge, Madison, Lancaster, Gage, Hall, Adams, Red Willow, and Scotts Bluff counties, and between said counties, over irregular routes. The transportation of railroad

train crews and their baggage is not allowed, and the HHS Designation is no.

Applicant is seeking to establish its initial published rate for use in its new services. The proposed rates contain a loading fee that includes the first five miles for its ambulatory, wheelchair, and wheelchair XL services. Each service has the same proposed per mileage charge after the initial five miles as well as the same cancellation fee. A review of Applicant's proposed rates in comparison to rates offered by similar carriers for similar services finds that the proposed rates are reasonable.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Lunjini Medical Transportation, LLC, LaVista, Nebraska, be, and it is hereby, authorized to establish its rates for its services effective January 25, 2021 as follows:
