BY THE HEARING OFFICER:

On April 6, 2020, Prosperity Properties, Inc., d/b/a Omaha Supportive Living ("Applicant") Omaha, filed an application seeking authority as a common carrier in Nebraska intrastate commerce in the transportation of passengers by sedan and van between points in Douglas County over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and HHS Designation is no. Notice of the Application was published in The Daily Record, Omaha, Nebraska, on April 7, 2020.

Timely protests were filed by Camelot Transportation, Inc.; Triumph Transportation, Inc.; WHC NE, LLC d/b/a zTrip d/b/a Airport Transportation d/b/a Van GO and My Sedan; WHC NE, LLC d/b/a Cornhusker Cab Company and zTrip; WHC NE, LLC d/b/a Happy Cab and zTrip; WHC NE, LLC d/b/a Checker Cab Company and zTrip; WHC NE, LLC d/b/a Yellow Cab Company and zTrip; and WHC NE, LLC d/b/a Safeway Cabs and zTrip (collectively "zTrip"). Protests were granted on August 21, 2020.

On December 23, 2020, I entered a Hearing Officer's Order granting Applicant's request to amend its Application. On January 11, 2021, Camelot Transportation, Inc. and Triumph Transportation, Inc., filed a Motion for Leave to Withdraw its Protest based upon Applicant's amendment request.

Based on the above, I find that the Motion for Leave to Withdraw Protest filed by Camelot Transportation, Inc. and Triumph

Transportation, Inc., should be granted and said protests be considered withdrawn.


### O R D E R
