## BY THE COMMISSION:

By application filed September 24, 2020, Kelly DeSive, ("Applicant") O'Neill, Nebraska, seeks to cancel the Certificate of Public Convenience and Necessity issued by the Commission in Docket No. B-1925 on August 2, 2017. The Commission granted Applicant the authority to provide transportation of passengers by sedan between points in Holt and Boyd counties, and between points in said counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. The transportation of railroad train crews is not allowed, and HHS Designation is Yes. Notice of this application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on December 23, 2020. No protests were filed.

Applicant requested cancellation of its certificate of authority due to its failure to pay its 2020 annual renewal payment in accordance with Neb. Rev. Stat.  $\S$  75-305, and the resulting civil penalty assessed of One Thousand Nine-Hundred Dollars ( $\S$ 1,900) in MCC-3196.02.1

Upon due consideration of this request, the Commission is of the opinion and finds that the request should be granted, and the authority granted to Kelly DeSive, O'Neill, Nebraska, in Docket No. B-1925 should be cancelled. All PSC plates assigned to Kelly DeSive must be returned to the Commission within ten (10) days of receipt of this Order.
