OPINION AND FINDINGS

On May 21, 2019, Richwood Transport of Nebraska, LLC ("Applicant"), Middleton, Wisconsin, filed an application seeking authority as a contract carrier in Nebraska intrastate commerce in the transportation of passengers in open class service between points in Douglas, Lancaster, Sarpy, Hall, Platte, Gage, Dodge, Madison, Lincoln, and Scotts Bluff counties over irregular routes pursuant to a contract with the Nebraska Department of Health and Human Services, a Medicaid-managed care organization under contract with NDHHS, or another agent working on behalf of NDHHS. The transportation of railroad train crews and their baggage is not authorized, and HHS Designation is yes. Notice of the Application was published in The Daily Record, Omaha, Nebraska, on July 1, 2019.

Timely protests were filed by Camelot Transportation, Inc.; Triumph Transportation, Inc.,; Comstock Corporation d/b/a Action Cab; WHC NE, LLC d/b/a zTrip; WHC NE, LLC d/b/a Cornhusker Cab Application No. B-1997

Company and zTrip; WHC NE, LLC d/b/a Happy Cab and zTrip; WHC NE, LLC d/b/a Checker Cab Company and zTrip; WHC NE, LLC d/b/a Yellow Cab Company and zTrip; and WHC NE, LLC d/b/a Safeway Cabs and zTrip. Said protest were granted September 12, 2019.

Hearing on this matter was scheduled for June 16, 2020. On May 11, 2020, the Hearing Officer entered an order granting Applicant's request to postpone the hearing. Since that time, Commission staff attempted several times to contact Applicant to schedule a planning conference and new hearing date with no success. On January 12, 2021, the Commission entered an Order of Pending Dismissal requiring Applicant to contact the Commission no later than January 28, 2021, or the application would be dismissed. Applicant did not contact the Commission by the deadline.

After due consideration and being fully advised in the premises, the Commission is of the opinion and finds that Application No. B-1997 should be dismissed.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. B-1997, Richwood Transport of Nebraska, LLC, Middleton Wisconsin be, and is hereby, dismissed.
