OPINION AND FINDINGS

On January 29, 2020, Brad Johnson d/b/a MVP Limousine ("Applicant"), Scottsbluff, Nebraska filed an application seeking authority as a common carrier in Nebraska intrastate commerce in the transportation of passengers by limousine between points in Perkins, Chase, Thomas, Logan, Hayes, Hitchcock, Red Willow, Frontier, Sioux, Scotts Bluff, Banner, Kimball, Cheyenne, Morrill, Box Butte, Dawes, Sheridan, Garden, Duel, Grant, Arthur, Keith, Lincoln, McPherson, Hooker, and Cherry counties and points between said counties over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and HHS Designation is no. Notice of the Application was published in The Daily Record, Omaha, Nebraska, on February 25, 2020. No Protests were filed, and the Application was processed pursuant to the Commission's Rule of Modified Procedure.

On May 5, 2020, the Commission entered an Order granting the application; however, Applicant never finalized its approval by complying with Neb. Rev. Stat. §§ 75-305 (fees), 75-307 (insurance), and 75-308 (rates) (Cum Supp. 2020), and with the rules and regulations of the Commission. Commission staff attempted to contact Applicant by mail, email, and telephone regarding the required compliance documents but received no communication regarding the application. On January 12, 2021, the Commission entered an Order of Pending Dismissal requiring Applicant to contact the Commission no later than January 28, 2021, or the application would be dismissed.

Subsequent to the issuance of the January 12, 2021 Order, Applicant informed Commission staff via telephone that it wished to withdraw its application. Commission staff requested the withdrawal request be filed in writing. To date, Applicant has not submitted the withdrawal request in writing, but has left a voicemail message expressing its desire to no longer pursue its application.

After due consideration and being fully advised in the premises, the Commission is of the opinion and finds that Application No. B-2011 should be dismissed.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. B-2011 Brad Johnson, d/b/a MVP Limousine, Scottsbluff, be, and is hereby, dismissed.
