## OPINION AND FINDINGS

On February 4, 2020, Omaha's Very Own Party Bus, LLC ("Applicant"), Omaha, Nebraska, filed an application seeking authority as a common carrier in Nebraska intrastate commerce in the transportation of passengers by bus in special party and charter service between points in Douglas and Sarpy counties, and points between said counties, over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and HHS Designation is no. Notice of the Application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on May 15, 2020. No Protests were filed, and the Application was processed pursuant to the Commission's Rule of Modified Procedure.

On July 28, 2020, the Commission entered an Order Granting the Application.  $^1$  On December 7, 2020, Applicant verbally informed the Commission that it no longer wished to pursue the application. Commission staff informed Applicant that such

request must be made in writing. On January 12, 2021, the Commission entered an Order of Pending Dismissal requiring Applicant to contact the Commission no later than January 28, 2021, or the application would be dismissed. To date, Applicant has not provided the Commission with the written request to withdrawal its application.

After due consideration and being fully advised in the premises, the Commission is of the opinion and finds that Application No. B-2012 should be dismissed.

## ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. B-2012 Omaha's Very Own Party Bus, LLC, Omaha, be, and is hereby, dismissed.
