## OPINION AND FINDINGS

On January 5, 2021, the Nebraska Public Service Commission ("Commission") entered an order in the above-captioned docket to order several named motor carriers to appear before the Commission to show cause as to why their certificates or permits of authority should not be suspended for failure to remit annual fees in accordance with Neb. Rev. Stat. § 75-305 (2018). Hearing on this matter was held January 26, 2021.

Subsequent to the Hearing, the following carriers remitted the required annual renewal forms, annual renewal payments, and proof of current insurance to the Commission:

American Eagle Van Lines, Inc.
Caring People Sudan
Hope Park Transport
Local Movers
Mo's Moving
Prime Time Shuttle Service
Senior Moving Services, LLC
Serving Nebraska Health Transport
Xtreme Ride, LLC

These carriers have compiled with Neb. Rev. Stat. § 75-305 (2018) by making the requisite payments and filing the necessary documentation. As such, staff recommends the above-mentioned carriers be dismissed from the docket. Furthermore, the carriers are on notice that failure to remit future annual renewal forms, fees, and proof of insurance prior to the January 1 deadline could result in suspension of their certificate or permit of authority.
