BY THE COMMISSION:

On August 13, 2019, Price's Party Patrol, LLC ("Applicant"), Lexington, filed on application seeking to extend its authority as a common carrier in Nebraska intrastate commerce in the transportation of passengers by limousine between all points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and HHS Designation is no.

Notice of the Application was published in The Daily Record, Omaha, Nebraska, on August 23, 2019. Timely protest was filed by VIP Limousine, LLC, which was granted on November 13, 2019.

On November 15, 2019, Applicant filed a motion to amend its application. The Hearing Officer granted Applicant's motion on November 19, 2019 as follows:

AUTHORITY SOUGHT

COMMON: Service the transportation of passengers and their baggage in limousine service between all points in Nebraska over irregular routes.

RESTRICTIONS: No trips may originate or terminate in Douglas, Lancaster, or Sarpy County. The transportation of railroad train crews and their baggage is not authorized. HHS Designation: No.

Subsequent to the application amendment, Protestants withdrew their protests. Application No. B-1797, Supplement No. 1 was then processed pursuant to the Commission's Rule of Modified Procedure.

On January 12, 2021, an Order of Pending Dismissal was entered setting a deadline of January 28, 2021 for action to be taken in this docket or Commission action would be taken to dismiss the application. Subsequent to the issuance of that Order, Applicant filed all required documentation.

O P I N I O N A N D F I N D I N G S

Applicant is a Nebraska limited liability company with its principal office in Lexington, Nebraska. Applicant has been authorized since 2011 as common carrier that provides transportation to passengers by limousine in a 50-mile radius of Lexington, Nebraska. Applicant is now seeking the authority to provide limousine services statewide, with the agreed-upon restriction to not originate or terminate any trips in Douglas, Lancaster, or Sarpy counties. Applicant states that it receives calls from all parts of the state for service and wants to have the ability to provide that service.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant is fit, willing, and able to properly perform the proposed services, and to conform to the provisions of Neb. Rev. Stat. §§ 75-301 to 75-322 (Cum. Supp. 2020) and the requirements, rules and regulations of the Commission thereunder.
2. The proposed intrastate service is or will be required by the present of future public convenience and necessity to the following extent:

CERTIFICATE AUTHORIZED:

SERVICE AND TERRITORY AUTHORIZED:

COMMON: the transportation of passengers and their baggage in limousine service between all points in Nebraska over irregular routes.

RESTRICTIONS: No trips may originate or terminate in Douglas, Lancaster, or Sarpy County. The transportation of railroad train crews and their baggage is not authorized. HHS Designation: No.

3. The application should be approved.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. B-1797, Supplement No. 1 be, and it is hereby, granted; and that upon compliance with the terms and conditions set forth in this Order, a Certificate of Public Convenience and Necessity shall be issued to Price's Party Patrol, LLC, Lexington, Nebraska, in Application B-1797, Supplement No. 1, authorize the operations set forth in the foregoing findings.

IT IS FURTHER ORDERED that Applicant shall not be issued the Certificate of Public Convenience and Necessity authorized by the Commission unless and until Applicant has fully complied, within a reasonable time from the effective date of this Order, with Neb. Rev. Stat. §§ 75-305 (fees), 75-307 (insurance), and 75-308 (rates), and with the rules and regulations of the Commission, and if upon expiration of such time Applicant has not complied with such terms and conditions, this Order shall, after reasonable notice to Applicant, be of no further force and effect.

IT IS FURTHER ORDERED that Applicant shall not conduct operations until a Certificate of Public Convenience and Necessity is issued.

IT IS FURTHER ORDERED that the operations authorized herein shall be subject to the terms, conditions, and limitations which have been, or may hereafter be prescribed by the Commission.
