BY THE COMMISSION:

On February 3, 2021, Champion Homes of Hastings, LLC ("Applicant"), Hasting, filed an application for authority to amend its rates as follows:

Description

Proposed Rate \$12.50/hour

Wait Time - waiting for a patient to finish a non-emergency appointment

Emergency action is requested.

OPINION AND FINDINGS

Applicant is a Nebraska Limited Liability Company with its principal business address in Hastings, Nebraska. Applicant was granted authority under Application No. B-1705 to transport passengers and their baggage that are clients of Champion Homes of Hastings, LLC, between points in Adams county, on the one hand, and, on the other hand, points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized. HHS Designation is yes.

In its application, Applicant is seeking to add a wait-time charge to its existing rates. The proposed charge would be for \$12.50 an hour. The charge would be applicable to any instance when Applicant's drivers must remain at a drop-off location and wait until after a client's appointment has been completed to provide a return trip to that client. Applicant is not amending any other rates on its rate schedule.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application, as Applicant's drivers tend to be required to wait for long periods of time to provide return trips and Applicant has no ability to alleviate the expenses associated with such waiting. These costs are further exacerbated during COVID-19 where it is

already difficult to meet expenses. The Commission therefore finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective February 17, 2021.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Champion Homes of Hastings, LLC, Hastings, be, and is hereby, authorized to amend its rates for its services effective February 17, 2021 as follows:
