#### BY THE HEARING OFFICER:

On September 18, 2020 Oceans Enterprise, LLC d/b/a Oceans Drive Transportation ("Applicant"), Omaha, filed an application seeking to amend its Certificate of Public Convenience and Necessity by removing the restriction on number of vehicles and operating radius within Cass, Douglas, Dodge, Washington, and Sarpy counties. Notice of the application was published in The Daily Record, Omaha, Nebraska, on September 22, 2020.

Timely protests were filed by Camelot Transportation, Inc. and Triumph Transportation, Inc. ("collectively "Protestants"). On November 5, 2020, I entered an Order granting the protests.

A hearing was scheduled for February 24, 2021. On February 22, 2021, Protestants Camelot Transportation, Inc. and Triumph Transportation, Inc. filed a joint Motion for Leave to Withdraw their protests. Protestants' withdrawal from this matter renders the hearing unnecessary.

Based on the above, I find that the joint Motion for Leave to withdraw the protests of Camelot Transportation, Inc. and Triumph Transportation, Inc., should be granted, that the protests should be withdrawn. Additionally, the hearing scheduled for Wednesday, February 24, 2021, should be cancelled.

### ORDER

IT IS THEREFORE ORDERED by the Hearing Officer that the protests filed by Camelot Transportation, Inc. and Triumph Transportation, Inc., be, and are hereby, withdrawn.
