BY THE COMMISSION:

On November 30, 2020, The Beautiful Life Family Home Care LLC d/b/a Beautiful Life Medical Transport ("Applicant"), Omaha, filed an application seeking to extend its authority as a common carrier in Nebraska intrastate commerce in the transportation of passengers by van, sedan, and SUV between points in Lancaster County over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and HHS Designation is yes.

Notice of the Application was published in <u>The Daily Record</u>, Omaha, Nebraska on December 3, 2020. Because no protests were filed, Application B-1976, Supplement No. 1, was processed pursuant to the Commission's Rule of Modified Procedure.

OPINION AND FINDINGS

Applicant is a Nebraska Limited Liability Company with its principal place of business in Omaha, Nebraska. Applicant has been authorized since 2019 as a common carrier that provides transportation to passengers by van in open class service between points in Cass, Dodge, Douglas, Sarpy, and Washington counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. Applicant is now seeking to extend its authority to provide open class service by van, sedan, and SUV between points in Lancaster county. Applicant's services will be utilized not

only by the community, but also as a contractor authorized for the Nebraska Department of Health and Human Services. Applicant will provide its services with five vehicles.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

- 1. Applicant is fit, willing, and able to properly perform the proposed services, and to conform to the provisions of Neb. Rev. Stat. §§ 75-301 to 75-322 (Cum. Supp. 2020) and the requirements, rules and regulations of the Commission thereunder.
- 2. The proposed intrastate service is or will be required by the present of future public convenience and necessity to the following extent:

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. B-1976, Supplement No. 1 be, and it is hereby, granted; and that upon compliance with the terms and conditions set forth in this Order, a Certificate of Public Convenience and Necessity shall be issued to The Beautiful Life Family Home Care LLC d/b/a Beautiful Life Medical Transport, Omaha

Nebraska, in Application B-1976, Supplement No. 1, authorize the operations set forth in the foregoing findings.

Supp. 2020), and with the rules and regulations of the Commission, and if upon expiration of such time Applicant has not complied with such terms and conditions, this Order shall, after reasonable notice to Applicant, be of no further force and effect.

IT IS FURTHER ORDERED that Applicant shall not conduct operations until a Certificate of Public Convenience and Necessity is issued.

IT IS FURTHER ORDERED that the operations authorized herein shall be subject to the terms, conditions, and limitations which have been, or may hereafter be prescribed by the Commission.
