BY THE COMMISSION:

On September 25, 2020, Limousine Gonzalez, LLC ("Applicant"), Waco, Nebraska, filed an application for authority as a common carrier in Nebraska intrastate commerce in the transportation of passengers by luxury and stretch limousine in limousine service between points in York, Seward, Lancaster, Saline, Filmore, Clay, Hamilton, Merrick, Polk, Butler, Saunders, Sarpy, Douglas, Cass, Otoe, Platte, Madison, Colfax, Dodge, Hall, Buffalo, Adams, Clay, and Merrick counties, and between said counties, over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and HHS Designation is No.

Notice of the application was published in The Daily Record, Omaha, Nebraska, on September 30, 2020. A timely protest was filed by was filed by VIP Limousine, LLC and granted on December 3, 2020. On November 16, 2020, Applicant filed a written request to amend its Application. On December 3, 2020, the Hearing Officer granted Applicant's written request to amend its application with the addition of the following restriction: trips may not originate in

Douglas and Sarpy counties. On December 9, 2020, the protestant filed a request to withdrawal its protest, which was granted on January 27, 2021. Application No. B-2020 was then processed pursuant to the Commission's Rule of Modified Procedure.

### O P I N I O N   A N D   F I N D I N G S

Applicant is a Nebraska Limited Liability Company with its principal place of business in Waco, Nebraska. Applicant seeks to provide passenger transportation by limousine in various counties throughout the eastern portion of Nebraska. Applicant will provide its services utilizing one limousine.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant is fit, willing, and able properly to perform the proposed service, and to conform to the provisions of NEB. REV. STAT. §§ 75-301 to 75-322 (Cum. Supp. 2020) and the requirements, rules and regulations of the Commission thereunder.
2. Upon compliance with NEB. REV. STAT. §§ 75-305 (fees), 75-307 (insurance), and 75-308 (rates) (Cum. Supp. 2020), and with the rules and regulations of the Commission, a Certificate of Public Convenience and Necessity should be issued as proposed:

### CERTIFICATE AUTHORIZED

#### SERVICE AND TERRITORY AUTHORIZED:

COMMON: Transportation of passengers by luxury and stretch limousine in limousine service between points in York, Seward, Lancaster, Saline, Filmore, Clay, Hamilton, Merrick, Polk, Butler, Saunders, Sarpy, Douglas, Cass, Otoe, Platte, Madison, Colfax, Dodge, Hall, Buffalo, Adams, Clay, and Merrick counties, and between said counties, over irregular routes.

RESTRICTIONS: The transportation of railroad train crews and their baggage is not authorized. Trips may not originate in Douglas and Sarpy counties. HHS Designation: No.

3. The application for authority should be granted.

## O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. B-2020 be, and it is hereby, granted; and that upon compliance with the terms and conditions set forth in this Order, a Certificate of Public Convenience and Necessity shall be issued to Limousine Gonzalez, LLC, Waco, Nebraska in Application No. B-2020, authorizing the operations set forth in the foregoing findings.

IT IS FURTHER ORDERED that Applicant shall not be issued the Certificate of Public Convenience and Necessity authorized by the Commission unless and until Applicant has fully complied, within a reasonable time from the effective date of this Order, with NEB. REV. STAT. §§ 75-305 (fees), 75-307 (insurance), and 75-308 (rates) (Cum. Supp. 2020), and with the rules and regulations of the Commission, and if upon expiration of such time Applicant has not complied with such terms and conditions, this Order shall, after reasonable notice to Applicant, be of no further force and effect.

IT IS FURTHER ORDERED that Applicant shall not conduct operations until a Certificate of Public Convenience and Necessity is issued.

IT IS FURTHER ORDERED that the operations authorized herein shall be subject to the terms, conditions, and limitations which have been, or may hereafter be prescribed by the Commission.
