BY THE COMMISSION:

On January 5, 2021, the Nebraska Public Service Commission ("Commission") entered an order in the above-captioned docket to order several named carriers to appear before the Commission to show cause as to why their certificates or permits of authority should not be suspended for failure to remit annual fees in accordance with Neb. Rev. Stat. § 75-305 (2018).¹ Hearing on this matter was held January 26, 2021.

On February 2, 2021, the Commission entered an Order to dismiss carriers, in part, and sustain action against the remaining carriers to the show-cause docket. In its Order, the Commission suspended the authorities of the named carriers and ordered said carriers to cease and desist all transportation services until such time as the named carriers completed their annual renewal requirements and the Commission entered an order to reauthorize the provisions of services.²

Subsequent to the Order, the following carriers remitted the required annual renewal fees, vehicle equipment lists, and proof of current insurance to the Commission:

Passenger Carriers: Davis Entertainment d/b/a Ollie the Trolley;

Household Goods Movers: A Helping Hand Moving, LLC

Commission staff recommends that these carriers be dismissed from the docket and their transportation services be reauthorized.

On March 8, 2021, a departmental complaint was filed against the remaining carriers whom had failed to remit their annual renewal fees prior to the March 1 delinquency deadline provided in Neb. Rev. Stat. § 75-305. On March 16, 2021, the Commission entered an Order to Show Cause and Schedule a hearing for that complaint.³ Respondents to the complaint included those carriers who have yet to have their operating authority reinstated pursuant to the February 2, 2021 Order in this docket. As such, those carriers who were subject to the suspension order by the Commission and who were subsequently named in the complaint are still barred from providing transportation services within the State of Nebraska under their certificates or permits of authority. Any efforts to regain compliance with Commission rules and regulations will be handled exclusively through the complaint.

Based on the above, the Commission finds that the carriers listed should be dismissed from this docket. The Commission also finds that the cease and desist against Davis Entertainment d/b/a Ollie the Trolley and A Helping Hand Moving, LLC should be removed and both may resume providing services. These carriers are on notice that failure to remit future annual renewal forms, fees, and proof of insurance on or before January 1 could result in Commission action.

In addition, the Commission finds that this docket should be considered closed and any further action relating to remittance of annual renewal fees will be handled exclusively through the motor carrier complaint.
