BY THE COMMISSION:

By application filed with the Commission on April 3, 2020, Ronald D. Allgood d/b/a Tree City Cab Company ("Tree City Cab" or "Applicant"), Nebraska City, Nebraska, requested a suspension of the Certificate of Public Convenience and Necessity issued in Application B-1320 until September 1, 2020.¹ The Commission entered an Order on August 25, 2020, granting an extension of suspension until January 3, 2021.² On January 26, 2021, the Commission entered an Order granting an additional extension of the suspension until March 21, 2021.³

On or around February 24, 2021, Applicant requested reinstatement of its certificate. Applicant has supplied proof of current insurance, confirmed its vehicles, and made the requisite payments for its fleet. Applicant is authorized to provide, with restrictions, transportation by taxicab between points in Otoe County on the one hand and points in Nebraska on the other, in addition to points between Otoe and Nemaha Counties over irregular routes using vans with a rated capacity of 12 passengers or less.

Upon due consideration of this request, the Commission is of the opinion and finds that the request should be granted and
