BY THE COMMISSION:

On March 2, 2021, Jamie L. Reyes, Director of the Motor Transportation Department ("Complainant") filed a complaint against the above-captioned Respondents alleging violation of Neb. Rev. Stat. § 75-305 (Cum. Supp. 2020). Complainant alleges that Respondents failed to timely file annual fees as required by § 75-305 by March 1, 2021.

After the filing of the Complaint, the following Respondents completed all annual renewal requirements:

Medics At Home, Inc.; Omaha Ambulance Service, Inc.; Omaha Omaha Handicap Transportation Services; Cornbelt Development d/b/a Travel Plus Limousine; and Unity Transportation Services, Inc.

The listed Respondents have complied with § 75-305 by making the proper annual renewal payments. As this was the first late renewal payment for these Respondents, each Respondent was granted a one-time waiver of any accrued administrative fine. By stipulation between Complainant and Respondents, staff recommends that the above-named Respondents should be dismissed from the Complaint. Respondents are on notice that failure to remit future annual renewal fee payments in a timely manner could result in administrative fines and costs.

National Arbor Day Foundation

National Arbor Day Foundation has complied with § 75-305 by making proper payment of its annual fees. National Arbor Day Foundation was eligible for a one-time waiver of any accrued administrative fine but elected not to request the waiver and instead pay its accrued administrative fine in accordance with the Department's fining schedule. Since the waiver is only available to carriers that had not been previously considered delinquent with remitting its annual fees, National Arbor Day Foundation will not be eligible to request a waiver of fines in the future.

By stipulation by Complainant and Respondent, staff recommends that National Arbor Day Foundation be dismissed from the Complaint. National Arbor Day Foundation is on notice that failure to remit future annual renewal fee payments in a timely manner could result in administrative fines and costs.

Ambassador Transportation

Ambassador Transportation, LLC paid its annual renewal fees on March 1, 2021 but failed to provide the Commission with its vehicle information required as part of the annual renewal. Staff has received all required documentation and Ambassador Transportation should therefore be dismissed from the Complaint. Ambassador Transportation is not subject to any administrative fines and remains eligible to receive a one-time waiver of administrative fines if named a Respondent in a future Complaint.

Fun Family Party Bus, LLC

Finally, FunFamily Party Bus, LLC has notified Commission staff that they are no longer in business. FunFamily has filed the appropriate paperwork to cancel its Certificate of Public Convenience and Necessity and the cancellation will be managed in a separate docket. Therefore, staff recommends dismissing FunFamily Party Bus, LLC from the Complaint.

Based on the above, the Commission finds Medics At Home, Inc.; Omaha Ambulance Service, Inc.; Omaha Omaha Handicap Transportation Services; Cornbelt Development d/b/a Travel Plus Limousine; Unity Transportation Services, Inc.; National Arbor Day Foundation; Ambassador Transportation; and FunFamily Party Bus, LLC should be dismissed from the Complaint.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Medics At Home, Inc.; Omaha Ambulance Service, Inc.; Omaha Omaha Handicap Transportation Services; Cornbelt Development d/b/a Travel Plus Limousine; Unity Transportation Services, Inc.; National Arbor Day Foundation; Ambassador Transportation; and FunFamily Party Bus, LLC be, and are hereby, dismissed from the Complaint.
