## BY THE COMMISSION:

By application filed with the Commission on or around April 12, 2019, Dashabout Roadrunner, Inc., ("Dashabout" or "Applicant"), Akron, Colorado, requested a suspension of the Certificate of Public Convenience and Necessity in Application B-1375 until May 1, 2020.¹ The Commission entered an Order on May 19, 2020, granting an extension of suspension until September 22, 2020.²

Applicant is a common carrier authorized to provide, transportation of passengers by van in open class service between points in Dundy, Hitchcock, Red Willow, Chase, Cheyenne, Hayes, Frontier, Perkins, Lincoln, Dawson, Keith, Deuel, Garden, Morrill, Furnas, Gosper, Harlan, Phelps, Buffalo, Kearney, Adams, Hall, Hamilton, York, Seward, Cass, Sarpy, Douglas, Lancaster, Hooker, McPherson, Thomas, Logan, Butler, Colfax, Madison, Merrick, Platte, Polk, Saunders, and Stanton counties, and between points in said counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. The following restrictions apply: the transportation of train crews and their baggage is not authorized; point-to-point service within the City of Lincoln is not authorized, except for transportation of friends or relatives of passengers already aboard which have originated or will terminate in communities out of Lincoln from the Lincoln Municipal Airport to medical facilities, the Lincoln University of Nebraska, Station, and/or the Cornhusker Hotel. Amtrak transportation of clients of Nebraska Department of Health and

Human Services, such as, but not limited to, Access to Care (AMR) and/or person in the custody of the Nebraska Department of Corrections, in capacity of such clients and/or persons in custody is not authorized in butler, Colfax, Madison, Merrick, Platte, Polk, Saunders, and Stanton counties. Applicant was granted its authority on June 27, 1994.

On or around March 31, 2021, Applicant requested reinstatement of its certificate. Applicant has supplied proof of current insurance, confirmed its vehicles, and made the requisite payments for its fleet. According to Commission staff, Applicant has completed all required compliance steps to reinstate its operations.

Upon due consideration of this request, the Commission is of the opinion and finds that the request should be granted and Certificate of Public Convenience and Necessity in Application B-1375 should be reinstated.

## ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the request of Dashabout Roadrunner, Inc., Akron, Colorado, to reinstate its Certificate of Public Convenience and Necessity is granted.
