#### BY THE COMMISSION:

By application filed December 21, 2020, Somebody with a Truck, LLC, ("Applicant"), Omaha, seeks authority to operate as a common carrier of household goods as follows:

## AUTHORITY SOUGHT

COMMON: Transportation of household goods between all points in Nebraska over irregular routes.

Notice of the application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on January 12, 2021. Because no protests were filed, Application M-14257 was processed pursuant to Commission's Rule of Modified Procedure.

### OPINION AND FINDINGS

Applicant is a Nebraska Limited Liability Company with its principal place of business in Omaha, Nebraska. Applicant seeks to provide household goods moving services as a common carrier in the proposed territory noted above. Applicant proposes to begin providing services with one vehicle in the proposed service territory.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant is fit, willing, and able to properly perform the proposed service, and to conform to the provisions of Neb. Rev. Stat. §§ 75-301 to 75-322 (Cum. Supp. 2020) and the requirements, rules and regulations of the Commission thereunder.

2. Upon compliance with Neb. Rev. Stat. §§ 75-305 (fees), 75-307 (insurance), and 75-308 (rates) (Cum. Supp. 2020), and with the rules and regulations of the Commission, a Certificate of Public Convenience and Necessity should be issued as proposed:

#### CERTIFICATE AUTHORIZED

SERVICE AND TERRITORY AUTHORIZED:
COMMON: Transportation of household goods between
all points in Nebraska over irregular routes.

3. The application for authority should be granted.

#### ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. M-14257 be, and it is hereby, granted; and that upon compliance with the terms and conditions set forth in this Order, a Certificate of Public Convenience and Necessity shall be issued to Somebody with a Truck, LLC, Omaha, Nebraska, in Application M-14257, authorizing the operations set forth in the foregoing findings.

IT IS FURTHER ORDERED that Applicant shall not be issued the Certificate of Public Convenience and Necessity authorized by the Commission unless and until Applicant has fully complied, within a reasonable time from the effective date of this Order, with Neb. Rev. Stat. §§ 75-305 (fees), 75-307 (insurance), and 75-308 (rates) (Cum. Supp. 2020), and with the rules and regulations of the Commission, and if upon expiration of such time Applicant has not complied with such terms and conditions, this Order shall, after reasonable notice to Applicant, be of no further force and effect.

IT IS FURTHER ORDERED that Applicant shall not conduct operations until a Certificate of Public Convenience and Necessity is issued.
