On March 30, 2021, Live Well Home Care, LLC ("Applicant"), Sioux City, Iowa, filed an application for authority to amend its rates as follows:

Notice of the Application was published in <u>The Daily Record</u>, Omaha, Nebraska, on April 2, 2021. No protests were filed.

### OPINION AND FINDINGS

Applicant is a Nebraska limited liability company with its principal place of business address in Sioux City, Iowa. Applicant was granted authority under Application B-1992 to transport passengers as a common carrier of Nebraska Intrastate Commerce in open class between points in Cedar, Cuming, Dakota, Dixon, and Thurston Counties and between points in said counties over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and HHS designation is yes.

Applicant is seeking to amend its existing rates previously granted under Rate Docket BR-562.¹ Applicant is seeking to increase its ambulatory base rate for the first five miles by \$5.00 for both its weekday rates and its weekend and off hours rates. Applicant also seeks to increase its wheelchair base rate for the first five miles by \$5.00 for its weekday rates and its weekend and off hours rates. Applicant is also proposing to add a cancellation fee of \$20.00 to both its ambulatory and wheelchair base rates. Applicant proposes to keep all other rates the same. A review of Applicant's proposed rates in comparison to rates offered by similar carriers for similar services finds that the proposed rates are reasonable.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted.

#### ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Live Well Home Care, LLC, Sioux City, Iowa, be, and it is hereby, authorized to establish its rates for its services effective May 16, 2021, as follows:
