On April 29, 2021, Mojo Mobility, LLC ("Applicant"), Omaha, filed an application for authority to amend its rates for use in its operations as follows:

OPINION AND FINDINGS

Applicant is a Nebraska limited liability company with its principal address in Omaha, Nebraska. Applicant is a permitted contract carrier that holds Permit No. B-1966. The permit authorizes Applicant to provide transportation to passengers by van and sedan in open class service between points in Thurston, Dakota, Cuming, Burt, Dodge, Washington, Douglas, Sarpy, Saunders, Cass, Otoe, Butler, Colfax, Lancaster, and Seward counties over irregular routes pursuant to contracts with the Nebraska Department of Health and Human Services ("NDHHS"), a Medicaid managed care organization under contract with NDHHS, or another agent working on behalf of NDHHS. HHS Designation is yes. The authority was granted on August 27, 2019.

Applicant is seeking to amend all its existing rates previously granted under Rate Docket No. BR-573.¹ Under Neb. Rev. Stat. § 75-304.01, the Commission shall prescribe a contract carrier's minimum rates, fares, and charges. Contract carriers shall not demand, charge, or collect less compensation for transportation than the charges to be made by common carriers for the same transportation. As Applicant is not seeking to lower its current rates, no approval from the Commission is necessary to begin implementing the ambulatory and wheelchair base rate/loading fee and mileage. However, the proposed rates for no-show or cancelation of the trip at the door are new rates to be considered pursuant to § 75-304.01. Upon review, the proposed rates are not lower than similar charges utilized by common carriers for the same transportation and are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. In its request, Applicant states that the number of overall trips has declined while at the same time Applicant has had an increase in no-show or cancelation of trips at the door since the beginning of the pandemic resulting in a strain on its finances. Applicant would like to be placed in a position to implement these rates as soon as possible to help mitigate any financial difficulties. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective May 11, 2021. No reduction shall be made in any of these charges except after ten (10) days' notice of the proposed change with the Commission. The notice should state the changes and when the changes will take effect.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Mojo Mobility, LLC, Omaha, Nebraska be, and is
