## BY THE HEARING OFFICER:

By application filed March 19, 2021, KozGo Inc. ("Applicant"), Omaha, seeks a permit to operate as a transportation network company ("TNC") in Nebraska. Applicant is a Nebraska corporation with its principal office in Omaha, Nebraska.

Applicant seeks approval to operate as a TNC in Nebraska pursuant to the provisions of NEB. REV. STAT. § 75-324(2)(c), which states an applicant that is not duly certified or permitted to operate as a TNC in at least one other state must demonstrate that (i) the applicant has sufficient financial resources to provide TNC services in the proposed service territory; (ii) the applicant has sufficient technical competency to provide TNC services in the proposed service territory; and (iii) the applicant has sufficient managerial resources to provide TNC services in the proposed service territory.

Applicant is not duly certified or permitted to operate as a TNC in at least one other state. Therefore, I find that a hearing in this matter is necessary to provide Applicant an opportunity to showcase that it is sufficiently competent to provide TNC services within the state of Nebraska. On or around April 20, 2021, Applicant filed supplemental documentation with Commission staff further detailing its financial, technical, and managerial resources. Applicant should be prepared to discuss those documents in detail and provide any additional information necessary to demonstrate that Applicant meets the requirements of NEB. REV. STAT. § 75-324(2)(c).

Hearing on this application will be held **Wednesday**, **May 26**, **2021** at **1:30 p.m**. in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska.
