On April 7, 2021, Limousine Gonzalez, LLC ("Applicant"), Waco, Nebraska, filed an application for authority to establish its rates as follows:

Full Day Package	\$450 for pickup and drop off services and wait time for a total of 8 hours

Notice of the Application was published in The Daily Record, Omaha, Nebraska on April 9, 2021. No protests were filed.

O P I N I O N A N D F I N D I N G S

Applicant is a Nebraska Limited Liability Company with its principal place of business in Waco, Nebraska. Applicant was granted authority under Application B-2020 to transport passengers by luxury and stretch limousine in limousine service between points in York, Seward, Lancaster, Saline, Filmore, Clay, Hamilton, Merrick, Polk, Butler, Saunders, Sarpy, Douglas, Cass, Otoe, Platte, Madison, Colfax, Dodge, Hall, Buffalo, Adams, Clay, and Merrick counties, and between said counties, over irregular routes. Trips may not originate in Douglas and Sarpy counties. HHS Designation is No.
