On May 25, 2021, Action Taxi & Limo, Inc. and AA Cabbies, Inc. d/b/a Siouxland Taxi ("Applicants"), Sioux City, Iowa, filed an application for authority to amend rates for taxi services as follows:

OPINION AND FINDINGS

Applicants are Iowa corporations with principal places of business in Sioux City, Iowa. Applicants are common carriers that provide transportation to passengers by taxicab between points in Dakota, Dixon, Thurston, and Wayne counties and between said counties on one hand, and, on the other hand, points in Nebraska over irregular routes. Each Applicant holds HHS Designation.

In the application, Applicants seek to amend and replace existing rates previously granted under Rate Dockets TR-206 and TR-207. Applicants' proposed rate increase in the drop rate and mileage rate result in a 10% increase from the previously approved rates. Existing minimum charges in and around South Sioux City, Nebraska would increase between \$0.50 and \$1.00. Finally, Applicant's fuel surcharges are proposed to be implemented when the price of fuel per gallon is \$1.70 instead of the current start point of \$4.00 per gallon. Under the proposed fuel surcharge, the surcharge would increase \$0.15 for every \$0.30 increase in fuel price when the price of fuel hits \$3.00. Charges for wait time remain unchanged. A review of Applicants' proposed rates in comparison to rates offered by similar carriers for similar services finds that the proposed rates are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application, as Applicants state that they have absorbed increases in several costs such as fuel and labor since the last rate increase for each carrier in 2016. Applicant should be placed in a position to improve its revenue and operations as soon as possible.
