OPINION AND FINDINGS

The Nebraska Public Service Commission ("Commission"), on its own motion, is seeking revocation of the Certificate of Public Convenience and Necessity granted to Premier Limousine, LLC, Columbus, in Docket No. B-2013.

The Commission granted Premier Limousine authority to operate and provide transportation by luxury or stretch limousine and sedan in Custer, Lincoln, Dawson, Buffalo, Sherman, Valley, Garfield, Loup, Blair, Thomas, Logan and Holt counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes, as a limousine service in Otoe County and between points within said county, on the one hand, and, on the other hand, points in Nebraska over irregular routes. Premier Limousine was not authorized to transport railroad train crews and their baggage and HHS designation was no. Premier Limousine was granted its authority on September 1, 2020.

Neb. Rev. Stat. \$ 75-305(1) requires all regulated motor carriers to pay an annual fee not exceeding eighty dollars (\$80) for each motor vehicle operated. Annual fees are due and payable to the Commission on or before January 1 and are delinquent March 1.1

Premier Limousine failed to pay its annual renewal fee as required by \$ 75-305(1) and was therefore named a Respondent in a Departmental Complaint opened March 2, 2021.² Hearing on the

Complaint was held on May 4, 2021. No representative of Premier Limousine appeared at the hearing.

A company representative signed for receipt of both the Complaint and the May 4, 2021 show cause hearing notice. Premier Limousine contacted the Commission, stating that the company was out of business. Commission staff informed the representative of how to cancel the certificate. However, no action was taken by any representative for Premier Limousine to resolve the Complaint, pay the annual fee, or to cancel its certificate. Department staff recommended at the hearing that the Certificate of Public Convenience and Necessity held by Premier Limousine be revoked and the carrier be assessed a civil penalty of three-thousand, eighthundred dollars (\$3,800). The Commission entered an Order on June 8, 2021 sustaining the Complaint against Premier Limousine and adopting the Department recommendation. To date, there has been no response.

Based on the above, the Commission is of the opinion and finds that the authority granted to Premier Limousine, LLC, Kearney, in Docket No. B-2013 should be revoked for failure to comply with Neb. Rev. Stat. § 75-305(1). All PSC plates assigned to Premier Limousine must be returned to the Commission within ten (10) days of the effective date of this Order. Moreover, the civil penalty of three-thousand, eight-hundred dollars, was assessed to Premier Limousine, LLC, in the Commission's June 8, 2021 Order. No subsequent applications for authority will be granted until the above-mentioned civil penalty is satisfied.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Certificate of Public Convenience and Necessity issued to Premier Limousine, LLC, Kearney, in Docket No. B-2013 be, and is hereby, revoked.
