By application filed May 5, 2021, Pride Ridge Home Care, LLC d/b/a Pride Ridge Medical Transport ("Applicant"), Bellevue, seeks authority to operate as a common carrier in Nebraska intrastate commerce as follows:

Notice of the application was published in <u>The Daily Record</u>, Omaha, Nebraska, on May 11, 2021. Because no protests were filed, Application No. B-2030 was processed pursuant the Commission's Rule of Modified Procedure.

OPINION AND FINDINGS

Applicant is a Nebraska Limited Liability Company with its principle business address in Bellevue, Nebraska. Applicant owns a home health care company and is seeking to provide transportation in addition to its current business practices. Applicant plans to operate two vehicles at the outset of its operations.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

- 1. Applicant is fit, willing, and able properly to perform the proposed service, and to conform to the provisions of Neb. Rev. Stat. §§ 75-301 to 75-322 (Reissue 2018) and the requirements, rules and regulations of the Commission thereunder.
- 2. The proposed intrastate service is or will be required by the following extent:

SERVICE AND TERRITORY AUTHORIZED:

COMMON: Transportation of passengers by sedan and van between points in Cass, Douglas, and Sarpy counties, and between said counties, over irregular routes.

3. The application for authority should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. B-2030 be, and it is hereby, granted; and that upon compliance with the terms and conditions set forth in this Order, a Certificate of Public Convenience and Necessity shall be issued to ride Ridge Home Care, LLC d/b/a Pride Ridge Medical Transport, Bellevue, Nebraska in Application No. B-2030, authorizing the operations set forth in the foregoing findings.

IT IS FURTHER ORDERED that Applicant shall not be issued the Certificate of Public Convenience and Necessity authorized by the Commission unless and until Applicant has fully complied, within a reasonable time from the effective date of this Order, with Neb. Rev. Stat. §§ 75-305 (fees), 75-307 (insurance), and 75-308 (rates) (Reissue 2018), and with the rules and regulations of the Commission, and if upon expiration of such time Applicant has not complied with such terms and conditions, this Order shall, after reasonable notice to Applicant, be of no further force and effect.

IT IS FURTHER ORDERED that Applicant shall not conduct operations until a Certificate of Public Convenience and Necessity is issued.
