## BY THE COMMISSION:

On September 26, 2017, the Nebraska Public Service Commission ("Commission"), on its own motion, opened the above-captioned docket to investigate possible changes to charges for transporting household goods pursuant to the Official Household Goods Tariff 7F and Official Intracity Household Good Tariff 22. This investigation worked in tandem with the Commission dockets MR- 1009/PI-70 and MR-1022/PI-216 to receive comment from the moving industry and make necessary updates to the rates and charges to each tariff.  $^1$ 

On August 11, 2020, the Governor signed LB 461, which made several changes to the Commission's regulation of household goods movers. Specifically, LB 461 removed the Commission's authority to fix rates and charges for intrastate household goods moving services and reproduce tariffs containing the rates and charges for transporting household goods as of July 1, 2021.<sup>2</sup> As a result, movers are now able to establish the rates and charges for their services and file those rates with the Commission periodically. The Official Household Goods Tariff 7F and Official Intracity Household Goods Tariff 22 are both void and will no longer be updated by the Commission. Therefore, no further action in this docket is necessary.
