O P I N I O N A N D F I N D I N G S

On October 6, 2020, the Nebraska Public Service Commission ("Commission"), on its own motion, opened the above-captioned docket to investigate actions that may be required in response to the passage of LB 461, passed by the Nebraska Legislature and signed by the Governor during the 2020 Legislative session.

LB 461 amended several statutes, including the removal of motor carriers that solely provide household goods services from the definition of regulated motor carrier, common carrier, and contract carrier. Effective July 1, 2021, those motor carriers were to be issued licenses before providing any transportation services in intrastate commerce.

On May 25, 2021, the Commission entered an Order prescribing the process for certificated household goods movers to transition to licensees. In that Order, the Commission found that ensuring a smooth transition for the current household goods movers to licensees was vital to avoid a potential lapse of service. All current certificated household goods movers were ordered to complete an affidavit process by June 30, 2021 to transition to a household goods mover licensee. Those certificated carriers who failed to complete the affidavit process by June 30, 2021 were put on notice that their Certificates or Permits of Authority would become null and void on July 1, 2021.

The carriers named in Appendix A, hereto attached to this Order, filed the necessary forms to successfully transition to licensees authorized to provide intrastate household goods moving service within the State of Nebraska. Pursuant to Neb. Rev. Stat. § 75-304.03, a license to provide household goods moving services is valid for one year and must be renewed annually.

Based on the above, the Commission finds that all carriers named in Appendix A are to be issued a license to provide household goods moving services within the State of Nebraska, effective July 1, 2021. A license issued by the Commission is valid for one year and may be renewed annually. If a licensee fails to renew its license prior to its renewal deadline, the license expires, and the licensee must reapply for and be granted a new license.

The Commission further finds that those carriers that failed to complete the transition process and any new carrier that wishes to provide household goods moving services in Nebraska must make application for a license to provide such services. The required application form and instructions are available by request and on the Commission website. Any previously certified household goods mover that did not complete the transition forms and receive a license from the Commission must cease and desist from providing any services in Nebraska until the Commission grants the mover a license to operate. Failure to do so may result in adverse Commission action.

Future granting of licenses will be processed and docketed under the applicant's unique license number.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that all carriers named in Appendix A be, and are hereby, issued licenses to provide intrastate household goods moving services within the State of Nebraska effective July 1, 2021.

IT IS FURTHER ORDERED that any household goods mover that failed to complete the transition process must cease and desist providing household goods moving services until an application for a license is filed and granted by the Commission.




