On May 3, 2021, the Nebraska Public Service Commission ("Commission") received a Form K Insurance Cancellation Notice for Ambassador Transportation, LLC ("Ambassador"), Omaha, who holds a Certificate of Public Convenience and Necessity under Certificate No. B-1989. The Form K received from Continental Insurance Company had a cancellation date of June 5, 2021. Commission staff sent Ambassador a letter dated May 3, 2021 regarding the cancellation notice and informing Ambassador that it must cease and desist any transportation services until a new insurance policy is in force. To date, no response or new insurance certificate has been received from Ambassador.

Pursuant to Commission Rule 006, all carriers are required to carry liability insurance in minimum amounts determined by the Commission. Additionally, carriers are required to file documents with the Commission that show proof of current insurance that meets the minimum insurance requirements.

After due consideration of the circumstances, the Commission finds that Ambassador Transportation, LLC, Omaha, should be ordered to show cause as to why its Certificate of Public Convenience and Necessity should not be suspended, modified, or revoked in whole or in part, for failure to maintain required liability insurance and provide proof of such insurance to the Commission in accordance with Commission Rule 006. Therefore, hearing on this matter shall be held on **Tuesday, September 14, 2021 at 1:30 p.m.** in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska.
