BY THE COMMISSION:

By application filed with the Commission on April 15, 2020, Red Star Transport, LLC ("Applicant"), Atkinson, Nebraska requested a suspension of the Certificate of Public Convenience and Necessity issued in Application B-1963 until June 18, 2020. The suspension was granted on April 21, 2020.<sup>1</sup>

Applicant is a common carrier authorized to provide transportation of passengers by bus in special party and charter between all points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and HHS designation is no. Applicant was granted its authority on March 6, 2018.

On or around July 20, 2021, Applicant requested reinstatement of its certificate. Applicant has supplied proof of current insurance, confirmed its vehicles, and made the requisite per-vehicle fee payments for its fleet. According to Commission staff, Applicant has completed all required compliance to reinstate its operations.

Upon due consideration of this request, the Commission is of the opinion and finds that the request should be granted and the Certificate of Public Convenience and Necessity in Application B-1963 should be reinstated.

## O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the request of Red Star Transport, LLC, Atkinson,
