BY THE COMMISSION:

On August 31, 2021, the Nebraska Public Service Commission ("Commission") entered an Order granting the rate application of Blair Blue Community Transportation, LLC ("Applicant"), Blair, on an emergency basis. After the entry of the Order, Applicant notified the Commission that a request to charge and collect \$2.75 for each drop off and pick up at Omaha Eppley Airfield was omitted from the Order.

## O P I N I O N     A N D     F I N D I N G S

The purpose of an order nunc pro tunc is to correct the record which has been made so that it will truly record the action taken which, through inadvertence or mistake, was not truly recorded.<sup>1</sup> Clerical errors may be corrected by an order nunc pro tunc, but not judicial errors.<sup>2</sup>

A review of the application shows that the rate was included in Applicant's rate request filed on August 17, 2021. The rate was mistakenly omitted and should have been included in the list of rates granted for Applicant on an emergency basis in the Commission's August 31, 2021 Order.

Based on the above, the Commission finds that an order nunc pro tunc should be entered. The rates listed on page one and three of the August 31, 2021 Commission Order granting Applicant's rates in Application BR-617 should be amended as follows:

Transportation (per car load up to 6 passengers)	
Base Rate	\$10.00
Per mile	\$2.25/mile
Extra Escort/Extended Wait	\$20.00/hour
Multi stops	\$0.50/stop
