BY THE HEARING OFFICER:

By application filed October 4, 2019, LaToya Prince Ventures, LLC ("Applicant"), Omaha, seeks authority as a contract carrier in Nebraska intrastate commerce in the transportation of passengers in open class service between all points in Nebraska over irregular routes pursuant to a contract with the Nebraska Department of Health and Human Services. HHS Designation is yes. Notice of the Application was published in The Daily Record, Omaha, Nebraska, on March 19, 2020. Timely protests were filed by Camelot Transportation, Inc.; Triumph Transportation, Inc.; WHC NE, LLC d/b/a Cornhusker Cab Company and zTrip; WHC NE, LLC d/b/a Happy Cab and zTrip; WHC NE, LLC d/b/a Checker Cab Company and zTrip; WHC NE, LLC d/b/a Yellow Cab Company and zTrip; and WHC NE, LLC d/b/a Safeway Cabs and zTrip (collectively "Protestants"). Protests were granted by the Hearing Officer on October 1, 2020.

The parties participated in a telephonic planning conference on June 16, 2020 to determine a procedural schedule and hearing date. Hearing was scheduled for August 26, 2020. Subsequent to the planning conference, Applicant's counsel withdrew from

representation and Applicant's discovery responses were not sent to Protestants. On November 30, 2020, Applicant filed a written request to continue the procedural schedule. Protestants did not object. The Hearing Officer granted Applicant's request on October 2, 2020.

To date, Applicant has not taken action to move the application forward. Commission staff have attempted to communicate by telephone and email with no response. Additionally, letters sent to Applicant's address on file were returned as unclaimed.

Therefore, the Commission enters this order of pending dismissal to put Applicant on notice that the application will be dismissed if no response to this Order is made on or before **October 22, 2021**. Applicant should indicate whether it intends to move forward with its application. If no response is received by **October 22, 2021**, the Commission will dismiss the application for failure to take timely action.





O R D E R
