BY THE COMMISSION:

On September 2, 2021, CareOne Transport Systems, LLC d/b/a CareOne, ("Applicant"), Omaha, filed an application for authority to establish its rates for use in its operations as follows:

One-way First 5 miles	\$50.00
Mileage rate	\$3.50/mile

Emergency action is requested.

O P I N I O N A N D F I N D I N G S

Applicant is a Nebraska limited liability company with its principal address in Omaha, Nebraska. On September 28, 2021, the Commission granted Applicant the authority to provide passenger transportation by van and sedan in open class service between points in Douglas, Dodge, Sarpy, Washington, Lancaster, Lincoln, Adams, Otoe, and Cass counties, and between said counties, over irregular routes. HHS Designation is yes.

Applicant is seeking to establish its initial published rates for use in its new services. Applicant proposes rates that consider expenses for providing both ambulatory and wheelchair transportation services without charging a separate, differential rate. A review of Applicant's proposed rates in comparison to rates offered by similar carriers for similar services finds that the proposed rates are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. In its request, Applicant states that it wants to begin services as soon as possible to provide a needed service. Therefore, the Commission finds that an emergency

basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective September 28, 2021. Moving forward, all future rate applications will be docketed under Applicant's authority number, B-2025 and these rates will be incorporated by reference.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that CareOne Transport Systems, LLC d/b/a CareOne, Omaha, Nebraska, be, and is hereby, authorized to amend its rates for its services effective September 28, 2021 as follows:
