O P I N I O N A N D F I N D I N G S

On August 25, 2021, the Nebraska Public Service Commission ("Commission") received a Form K Insurance Cancellation Notice for Ride the Good Life d/b/a Ride the Good Life, LLC ("Ride the Good Life"), Omaha, who holds a Certificate of Public Convenience and Necessity under Certificate No. B-1933. The Form K received from Columbia Insurance Company had a cancellation date of September 21, 2021.

Pursuant to Commission Rule 006, all carriers are required to file documents with the Commission that show proof of current insurance that meets the minimum insurance requirements.¹ Ride the Good Life was notified by letter of the cancellation notice and advised to cease and desist any operations if proof of insurance was not filed by the policy cancellation date. To date, the Commission has not received a current Form E Insurance filing and the carrier has not responded to the letter.

After due consideration of the circumstances, the Commission finds that Ride the Good Life d/b/a Ride the Good Life, LLC, Omaha, should be ordered to show cause as to why its Certificate of Public Convenience and Necessity should not be suspended, modified, or revoked in whole or in part, for failure to maintain required liability insurance and provide proof of such insurance to the Commission in accordance with Commission Rule 006. Therefore, hearing on this matter shall be held on **Tuesday, November 30, 2021 at 9:30 a.m.** in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska.
