On May 20, 2021, Prosperity Properties, Inc. d/b/a Omaha Supportive Living ("Applicant"), Omaha, filed an application for authority to establish its rates and charges as follows:

Notice of the application was published in The Daily Record, Omaha, Nebraska, on May 5, 2021. No protests were filed.

O P I N I O N A N D F I N D I N G S

Applicant is a Nebraska Corporation with its principal business address in Omaha, Nebraska. On April 13, 2021, Applicant was authorized in Application No. B-2015 as a contract carrier to provide transportation to passengers that are residential clients and/or individuals receiving services from Omaha Supportive Living by sedan and van in open class serve between points in Douglas County over irregular routes pursuant to service contracts with Prosperity Properties, Inc. d/b/a Omaha Supportive Living. HHS Designation is yes and limited to clients transported pursuant to contract.

Applicant is seeking to establish its initial published rates for use in its operations. The proposed rates will be the

rates that Applicant will use pursuant to its contract services. Under Neb. Rev. Stat. § 75-304.01, the Commission shall prescribe a contract carrier's minimum rates, fares, and charges. Contract carriers shall not demand, charge, or collect less compensation for transportation than the charges to be made by common carriers for the same transportation. Upon review, Applicant's proposed rates are not lower than those rates utilized by common carriers providing the same type of transportation and are reasonable.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted. No reduction shall be made in any such charge except after ten (10) days' notice of the proposed change to the Commission. The notice should state the changes and when the change will take effect.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Prosperity Properties, Inc. d/b/a Omaha Supportive Living, Omaha, Nebraska, be, and is hereby, authorized to amend its rates for its services effective October 24, 2021 as follows:
