On October 27, 2021, Camelot Transportation, Inc. ("Applicant"), Kearney, filed an application for authority to amend its rates by eliminating all previously granted rates and replacing those rates as follows:

OPINION AND FINDINGS

Applicant is a Nebraska Corporation with its principal place of business in Kearney, Nebraska. Applicant is a certified carrier that holds Certificate B-1802. The Certificate authorizes Applicant to provide transportation of passengers and their baggage in open class service between points in Nebraska over irregular routes. The transportation of railroad train crews is not authorized, and HHS Designation is yes.

Applicant is seeking to amend its existing rates previously granted under Rate Docket BR-472.¹ Applicant is seeking an increase to its base rate pick up fee, which includes the first five miles, by \$3.00. Applicant further proposes an increase of \$0.25 to its per mileage charge starting at mile six. In addition, Applicant seeks an increase of \$5.00 to both its additional passenger and wait time charge. Finally, Applicant proposes an increase of \$10.00 to its second driver or assistant charge. A review of Applicant's proposed rates in comparison to rates offered by similar carriers for similar services finds that the proposed rates are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this Application, as Applicant would like to recover appropriate costs associated with higher fuel prices and employee wages. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective November 2, 2021.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Camelot Transportation, Inc., Kearney, Nebraska, be, and is hereby, authorized to amend its rates for its services effective November 2, 2021 as follows:
