By application filed June 23, 2021, Richwood Enterprises d/b/a Richwood Transport ("Applicant"), Fremont, seeks approval of the acquisition of the operating rights and authority granted to Fremont Cab Service, LLC, Fremont, in Certificate No. B-1702. Notice of the application was published in The Daily Record, Omaha, Nebraska, on August 3, 2021. No protests were filed.


## O R D E R
