## O P I N I O N     A N D     F I N D I N G S

On October 19, 2021, the Nebraska Public Service Commission ("Commission"), entered an Order requiring Tim Whitney d/b/a Tri-City Limousine Service ("Tri-City"), Kearney, to show cause why his Certificate of Public Convenience and Necessity should not be suspended, modified, or revoked for failure to maintain required liability insurance and provide proof of such insurance to the Commission in accordance with Commission Rule 006. Tri-City's liability insurance policy cancelled September 27, 2021.

A show-cause hearing was scheduled for November 30, 2021. On October 29, 2021, the Commission received a Form E Certificate of Insurance from Columbia Insurance Company certifying that Tri-City has an insurance policy that complies with Commission rules and regulations. Because Tri-City has come into compliance with Commission rules, a show-cause proceeding is no longer necessary. Tri-City is strongly advised to ensure either continuous insurance coverage is on file with the Commission or to arrange to suspend its authority should it encounter difficulties with maintaining insurance coverage in the future.

Upon being fully advised in the premises, the Commission finds that the show-cause docket ordered against Tim Whitney d/b/a Tri-City Limousine Service should be dismissed and the November 30, 2021, hearing should be cancelled.

## O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the show cause entered against Tim Whitney d/b/a Tri-City Limousine Service, Kearney, Nebraska, be and it is hereby
