O P I N I O N A N D F I N D I N G S

On October 4, 2021, the Nebraska Public Service Commission ("Commission") received a Form K Insurance Cancellation Notice for WADD I, LLC d/b/a Wings of Love, LLC ("Wings of Love"), Omaha, who holds a Certificate of Public Convenience and Necessity under Certificate No. B-1745. The Form K received from National Continental Insurance Company had a cancellation date of November 4, 2021.

Pursuant to Commission Rule 006, all carriers are required to file documents with the Commission that show proof of current insurance that meets the minimum insurance requirements. Wings of Love was notified by letter of the cancellation notice but did not respond to the letter or any department outreach. To date, the Commission has not received a current Form E Insurance filing and the department has notified the carrier to cease and desist any operations.

After due consideration of the circumstances, the Commission finds that WADD I, LLC d/b/a Wings of Love, LLC, should be ordered to show cause as to why its Certificate of Public Convenience and Necessity should not be suspended, modified, or revoked in whole or in part, for failure to maintain required liability insurance and provide proof of such insurance to the Commission in accordance with Commission Rule 006. Therefore, hearing on this matter shall be held on **Tuesday, December 7, 2021 at 11:00 a.m.** in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska.
