On October 18, 2021, Standfast Transportation ("Applicant"), Omaha, filed an application to amend its rates and charges as follows:

Notice of the application was published in The Daily Record, Omaha, Nebraska, on October 29, 2021. No protests were filed.

O P I N I O N A N D F I N D I N G S

Applicant is a certificated common carrier providing passenger transportation in open class service by van between points in Douglas, Sarpy, Dodge, and Cass counties over irregular routes. HHS Designation is yes. Applicant was granted its authority in 2010.

In the current application, Applicant seeks to amend its rate for within Omaha city limits by increasing the rate from \$15.95 per trip to \$16.95 per trip. No other changes were requested. After comparison of the proposed rates with rates of other comparable providers, we determine that Applicant's rate request is reasonable.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Standfast Transportation, Omaha, Nebraska be, and it is hereby, authorized to amend its rates for its services effective December 12, 2021 as follows:
