On October 12, 2021, Omaha Omaha Handicap Transportation Services, Inc. ("Applicant"), Omaha, filed an application to amend its rates and charges as follows:

Notice of the application was published in The Daily Record, Omaha, Nebraska, on November 1, 2021. No protests were filed.

O P I N I O N A N D F I N D I N G S

Applicant is a certificated common carrier providing passenger transportation in open class service by van between points in Douglas County over irregular routes. HHS Designation is yes. Applicant was granted its authority in 2014 and has not amended its rates since that time.¹

In the current application, Applicant seeks to amend its base charge rates by increasing the one-way rate by two dollars and the round trip by four dollars. Applicant also proposes to add a charge for escort passengers. No other changes were requested. After comparison of the proposed rates with rates of other comparable providers, we determine that Applicant's rate request is reasonable.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Omaha Omaha Handicap Transportation Services, Inc., Omaha, Nebraska be, and it is hereby, authorized to amend its rates for its services effective December 12, 2021 as follows:
