BY THE COMMISSION:

On July 20, 2022, Legacy Party Bus ("Applicant"), Aurora, filed an application for authority to establish its rates for use in its operations as follows:

Emergency action is requested.

O P I N I O N A N D F I N D I N G S

Applicant is a Nebraska limited liability company with its principal office in Aurora, Nebraska. On June 8, 2021, Applicant was granted authority to provide passenger transportation by bus in special party classification over all points in Nebraska over irregular routes.

Applicant is seeking to establish its initial rates to be used in its services. A review of Applicant's proposed rates in comparison to rates offered by similar carriers for similar services finds that the proposed rates are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. Applicant would like to be able to begin services as soon as possible. The Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.
