In its application, Applicant seeks an order from the Commission approving a name change to Beautiful Life Medical Transport, LLC.

Upon consideration of Applicant's filing and the files and records of the Commission relative to Applicant and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant has changed its name, but no other aspect of the organization of Applicant has changed.
2. The authority held by Applicant should be carried in the files of the Commission in the new name of the Applicant to wit: Beautiful Life Medical Transport, LLC.
3. No further action or relief should be granted pursuant to Applicant's notification and request for official recognition of its new name.
