BY THE COMMISSION:

By application filed November 17, 2021, Shiloh Place, LLC ("Applicant"), Fremont, filed an application seeking to extend its existing authority. Notice of the application was published in The Daily Record, Omaha, Nebraska, on December 20, 2021. No protests were filed; therefore, the application was processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

Applicant is a Nebraska limited liability company with its principal business office in Fremont, Nebraska. Applicant currently provides transportation of passengers and their baggage as a contract carrier by van in open class service in Dodge County, and between points in Dodge County, on the one hand, and, on the other hand, points in Nebraska over irregular routes. Transportation is limited the residents of Shiloh Place ALF. The transportation of railroad train crews and their baggage Is not authorized, and HHS Designation is yes.

The proposed application would authorize Applicant to provide transportation services as a contract carrier between all points

in Nebraska. Applicant would be restricted to providing services to residents of Shiloh Place Assisted Living and participants/clients of Shiloh Center Adult Day Services.

After due consideration and being fully advised in the premises, the Commission is of the opinion and finds:

1. The proposed contract carrier operation is consistent with the public interest.
2. The application should be granted to the following extent:

PERMIT AUTHORIZED

SERVICE AND TERRITORY AUTHORIZED:

CONTRACT: transportation of passengers by van in open class service between all points in Nebraska over irregular routes pursuant to service contracts with Shiloh Center, LLC, and Shiloh Place Adult Day Services.

RESTRICTIONS: Limited to residents of Shiloh Place Assisted Living and participants/clients of Shiloh Center Adult Day Services. HHS Designation: Yes - limited to clients transported pursuant to contract.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. B-1888.01, be, and it is hereby granted; and that upon compliance with the terms and conditions set forth in this Order, a Permit of Authority shall be issued to Shiloh Place, LLC, Fremont, Nebraska in Application B-1888, authorizing the operations set forth in the foregoing findings.

IT IS FURTHER ORDERED that Applicant shall not be issued the Permit of Authority authorized by the Commission unless and until Applicant has fully complied within 45 days from the effective date of this order, with Neb. Rev. Stat., sections 75-305 (fees), 75-307 (insurance), and 75-308 (rates) (Cum. Supp. 2020), and with the rules and regulations of the Commission; and if upon expiration of such time Applicant has not complied with such terms and conditions, this order shall, after reasonable notice to Applicant, be of no further force and effect.

IT IS FURTHER ORDERED that Applicant shall not conduct the operations until a Permit of Authority is issued.
