BY THE COMMISSION:

On November 15, 2021, Beautiful Life Medical Transport, LLC ("Applicant"), Omaha, Nebraska, filed an application for authority to amend its rates and charges by altering its base rate charges and its wait time and cancellation charges for trips completed during off-hours, weekends, and holidays. Emergency action is requested.

OPINION AND FINDINGS

Applicant is a Nebraska Limited Liability Company with its principal place of business in Omaha, Nebraska. Applicant is a certificated carrier that holds Certificate B-1976. The Certificate authorizes Applicant to provide transportation of passengers by van in open class service between points in Cass, Dodge, Douglas, Sarpy, and Washington counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. HHS designation is yes. Applicant is further authorized to transport passengers by van, sedan, and SUV between points in Lancaster County over irregular routes, and the HHS designation is yes.

Applicant is seeking to amend its existing rates previously granted under B-1976.01r by altering its base rate for both its weekday and weekend/off-hours/holiday services.¹ Applicant seeks to reconfigure its base rate for its weekday services by charging \$45.00 and \$4.00 per mile, starting at the first mile. Applicant seeks to reconfigure its base for its weekend/off-hours/holiday services by charging \$55.00 and \$4.00 per mile, starting after the first three miles. Applicant also seeks to decrease its

cancellation rate for its weekend/off-hours/holiday services to \$45.00 and its wait time rate to \$45.00 per 30 minutes.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this Application as Applicant states that clarification was needed for its most recently approved rates regarding the change in its mileage charges, and Applicant wishes to utilize its clarified rates as soon as possible. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective March 1, 2022. Applicant's complete list of approved rates and charges are attached to this Order as Appendix A.

O R D E R


