#### BY THE COMMISSION:

On May 7, 2021, Barley Bus, LLC d/b/a Barley Bus Tours ("Applicant"), Kansas City, Missouri, filed an application for authority to establish its rates and charges for its use in its special party operations. Notice of the Application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on May 14, 2021. No protests were filed.

#### OPINION AND FINDINGS

Applicant is a Missouri Limited Liability Company with its principal office in Kansas City, Missouri. Applicant is a certificated carrier that holds Certificate B-2023, which authorizes Applicant to provide passenger transportation by bus in charter and special party service between points within a 75-mile radius of the city of Omaha over irregular routes. HHS designation is no.

Applicant is seeking to establish its initial published rates in order to provide transportation services within its service territory. Applicant proposes a rate of \$65 per person for services provided Sunday through Friday and \$70 per person for services provided on Saturday. A review of Applicant's proposed rates finds that the proposed rates are reasonable.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted effective March 6, 2022. Applicant's complete list of approved rates and charges are attached to this Order as Appendix A.
